REGULAR BOARD MEETING

The regular meeting of the Board of Education District No. 600 was called to order by President Eric Bandy at 7:00 P.M. on Monday, August 19, 2024. ASST. PRINCIPAL'S REPORT – Asst. Principal Wolfe reported that the beginning of the year is going well. We did have 4 referrals so far.

PRINCIPAL'S REPORT – Principal Boles reported our enrollment includes 200 Freshman, 167 Sophomores, 174 Juniors, and 178 Seniors for a total of 719. Freshman Orientation was August 13 from 12 to 3 p.m. They received their iPads, Jenny Knapp and Kyla Motch along with the Peer Helpers gave building tours and mini-sessions were presented by Mr. Lameczyk, Technology; Mr. Lever, Technology; Mrs. Nix and Mrs. Kessler, Cafeteria and fingerprinting; Mrs. Kaston, Media Center; Office Vieira and Mr. Wolfe, attendance procedures and rules; and TSS Photography, school pictures. He reported that overall it was a good start for our Freshmen.

SUPERINTENDENT'S REPORT – SUMMER RENOVATION PROJECT – Supt. Detering reported that the hallway renovation project is substantially complete; we are finalizing the hallway door signage, the weight room looks phenomenal, the gym sound system is great; on 2nd floor in Mr. Donoho's room they are testing vinyl planking to cover the old tiles. The lockers, floor tiles look really good and the student services department remodel is a great improvement. Discussion was held. TEACHER-ADMINISTRATOR SALARY REPORT– Supt. Detering presented the Board with the Teacher-Administrator Salary Report. This is a required annual approve and the report will be posted on the school website after approval. STRONGER CONNECTIONS GRANT – Supt. Detering reported that we received an initial confirmation of our Stronger Connections grant being funded. This grant will allow us to print a magazine to

send to all mailboxes. Discussion was held. COMPUTER SCIENCE EQUITY GRANT – Supt. Detering reported that we will update our computer lab with this grant.
